FOCUSING ON VARIOUS THEMES, SUCH AS WOMEN'S EQUITY DAY, WHICH RECOGNIZES THE RATIFICATION OF THE 19TH AMENDMENT ON AUG 18, 1920, GIVING WOMEN THE RIGHT TO VOTE, EACH EVENT SEEKS TO BRING WOMEN FROM DIVERSE CULTURES AND EXPERIENCES TOGETHER THROUGH THE SHARED CONNECTION OF THE HEADSCARF AND ITS COMPLEXITY.

PUBLIC PROGRAMMING:
